- Restricted Stock Units granted by the Issuer pursuant to its 2011 Stock Option and Incentive Plan and qualified under Rule 16b-3(d). Each unit represents a contingent right to receive one share of the Issuer's Common Stock.
- The Restricted Stock Units will vest in three (3) tranches. Of the 4,000 Restricted Stock Units granted, 1,333 will vest on January 17, 2013, 1,333 will vest on January 17, 2014, and 1,334 will vest on January 17, 2015, in each case if the Reporting Person remains employed by the Issuer on such date. The Restricted Stock Units do not have an expiration date.
- Options granted by Issuer pursuant to its 2011 Stock Option and Incentive Plan and qualified under Rule 16b-3(d).
- The options will vest in four (4) tranches. Of the 12,000 options granted, 3,000 options will vest on January 17, 2013, 3,000 options will vest on January 17, 2014, 3,000 options will vest on January 17, 2015, and the remaining 3,000 options will vest on January 17, 2016, in each case if the Reporting Person remains employed by the Issuer on such date.
